- Member must be present and has to identify oneself by informing our staff prior to billing to enjoy the membership benefits.
- No discount or JPP Points will be issued if member is not present at the point of billing. Date of birth may be requested for verification purposes.
- Discount and earning of JPP Points are not applicable with use of e-vouchers, promotional and discounted item(s), bank/merchant vouchers, purchase of JP Pepperdine gift vouchers and festive items unless otherwise stated.
- Discount and earning of JPP Points are not applicable on transaction(s) made on eve of/and on Public Holidays and Special Occasions such as Valentine's Day, Mother's Day and Father's Day.

## Terms and Conditions

### REDEMPTION OF JPP POINTS AND E-VOUCHERS

- Member is required to redeem existing JPP Points via member's portal before redemption at participating restaurants.
- One e-voucher can only be redeemed in one bill. Splitting of bill(s) is strictly not allowed.
- Redemption of e-voucher can be redeemed on the next visit and cannot be used in conjunction with member's discount and earning of JPP Points.
- Redemption of e-voucher is not valid on eve of/and on Public Holidays & Special Occasions such as Valentine's Day, Mother's Day and Father's Day.
- Member must be present to redeem e-voucher and has to identify oneself by informing our staff prior to ordering.
- JPP Points and e-vouchers cannot be exchanged for cash, vouchers or membership renewal.
- JPP Points and e-vouchers are non-extendable and will be forfeited upon expiry.

### EXPIRY OF MEMBERSHIP & RENEWAL

- Renewal can be done 1 month before expiry at a fee of \$18.
- Membership can be renewed on Members' Portal at [www.jppepperdine.com/members](http://www.jppepperdine.com/members) or at any of our participating restaurants.
- Expiry reminders will be sent 1 month before the expiration date of the membership.
- All accumulated JPP Points will expire at the end of the annual membership cycle, irregardless of early renewal.
- New membership year will commence upon expiration of the current membership cycle.

### TERMINATION AND CANCELLATION

- Member may, at any time, terminate the membership before expiry date with a written notice e-mailed to [members@jppepperdine.com](mailto:members@jppepperdine.com)
- In the event of early termination, membership expiry will be as of date of termination. Member shall not attempt to enjoy member privileges thereafter as such acts will be deemed fraudulent.
- Upon termination or cancellation, no refunds will be allowed and balance JPP points will be forfeited. Member shall not have further claim against us.
- The management reserves the rights to terminate any account in the event of any breach of Terms and Conditions.
